

# Efficient Monte Carlo algorithms for risk allocation

Motivated by the problem of risk allocation (the process of splitting the risk of a portfolio amongst its constituents), I will present algorithms for the computation of expectations conditional to rare events. The algorithms will be based on Sequential Monte Carlo methods and recent pseudo-marginal techniques will be used to perform parameter estimation together with the expectation calculation.
